HOURS - Show dates are Dec. 27th-Dec. 31st , opening on Wednesday and closing after the races on Sunday. The show opens at 9:00 am and closes at midnight each day. All booths must be open and staffed during show hours (except during races).

**MOVE IN/OUT - Exhibitors may begin moving into the building on Monday December 26 from 10:00 p.m. until 8:00 p.m. ONLY. Everyone MUST be moved in by Tuesday, December 26th, Wednesday is a practice and race day and we will not be able to move in on practice/race day . Move-out is Sunday, December 31st from Midnight until done, or Monday (if you wait until Monday there is no security Sunday night). ABSOLUTELY NO EARLY MOVE -OUT.**

BOOTHS - The promoter will provide a standard booth identification sign, back and side draperies.

BOOTH SHARING - Representatives staffing any booth must be employed by the exhibitor. If booth space is shared with an unrelated company, a charge will be assessed.

BOOTH ASSIGNMENTS: After November 17, 2023 booths will be assigned by date of payment received.
