HOURS - Show dates are January 3rd-Jan 5th, opening on Wednesday and closing on Saturday. The show opens at 9:00 am and closes at midnight each day. All booths must be open and staffed during show hours (except during races).

MOVE IN/OUT - Exhibitors may begin moving into the building on Monday December 28 from 12:00 p.m. until 8:00 p.m., and Tuesday 9:00 a.m. until 8:00 p.m. ONLY. Everyone MUST be moved in by Tuesday, December 29th, Wednesday is a practice and race day and we will not be able to move in on practice/race day. Move-out is Saturday, January 2nd from Midnight until done, or Sunday (if you wait until Sunay there is no security Saturday night). ABSOLUTELY NO EARLY MOVE -OUT.

BOOTHS - The promoter will provide a standard booth identification sign, back and side draperies.

BOOTH SHARING - Representatives staffing any booth must be employed by the exhibitor. If booth space is shared with an unrelated company, a charge will be assessed.
